Chancellor's Scholarship -

- 1. Will be provided based on the last semester result and attendance more than 80% in the current semester.
- 2. Provision of Chancellor's Scholarship will not applicable on those students who have doing only project work.
- 3.If there is minor project the scholarship will be provided based on the marks of the theory and other practical projects.
- 4. Those students who have got there admission based on the scholarship, will not able to Chancellor's scholarship.
- 5. For those students who have RAWE, Project or Field Training in their previous exam, the calculation will be done on the basis of their attendance in the previous exam.

1. Post Metric Scholarship for SC (Department Post Metric Scholarship for SC)

2. AWAS Sahayta Scheme SC/ST

- 1. SC/ST students who are residing on rent for study and studying in the institution
- 2. Documents required for the above scholarship: No objection certificate from Landlord on 10Rs stamp Paper, Declarations on Rs 10 stamp paper for not having own house in Satna city. Samagra ID, Photocopy of MP Permanent Domicile Certificate, Photocopy of Income Certificate, Photocopy of Cast Certificate, photocopy of 5th and 10th Mark sheet, Photocopy of recently passed exam, photocopy of Adhaar Card, Photocopy of Bank Passbook, Photocopy of TC, Photocopy of Fees receipt, GAP Certificate (If Applicable), 2 Passport size photo.

3. Ganv ki Beti Scheme

- The objective of the scheme is to provide financial assistance to encourage talented girls of rural areas to acquire higher education. Scholarships are given every year for the girls who have received 60% or more marks in the 12th examination.
- 2. **Documents required for the above scholarship:**12th Mark sheet photocopy, Certificate from Sarpanch for domicile of village, photocopy of Bank Passbook, Passport size photo

4. Pratibha Kiran Scheme

- 1. The objective of this scheme is improved educational standard of girls belonging to urban BPL families, who pass their 12th exam in the first division. But she has to take admission in higher classes the same year.
- 2. **Documents required for the above scholarship:**12th Mark sheet photocopy, BPL Certificate, photocopy of Bank Passbook, Passport size photo, Domicile Certificate

5. DIVYANG Scholarship

- Scholarship for Students with Disabilities. Students who are disabled more than 41% and their Guardian Parents income is more than 96,000 per Annum.
- Documents required for the above scholarship: Disable Certificate, Income Certificate, recently passed Mark sheet photocopy, photocopy of Bank Passbook, Passport size photo.
